**Technical Guide November 2010 Criteria**

- 2 available credits
- Credits worth 1.17% points each
- Mandatory Element: No

Aim: To promote the provision or purchase of energy efficient white goods, thus reducing the CO2 emissions from appliance use in the dwelling.

Assessment Criteria:

## Criteria

Where the following appliances are provided and have an **A+** rating under the *EU Energy Efficiency Labelling Scheme*:

- Fridges and freezers or fridge-freezers

Where the following appliances are provided and have an **A** rating under the EU Energy Efficiency Labelling Scheme:

- Washing machines and dishwashers

### **AND EITHER**

- Tumble dryers or washer dryers have a **B** rating (where a washer dryer is provided, it is necessary to also provide a washing machine)

### **OR**

- 2 available credits
- Credits worth 1.26% points each
- Mandatory Element: No

Aim: To encourage the provision or purchase of energy efficient white goods, thus reducing the CO2 emissions from appliance use in the dwelling.

Assessment Criteria: Credits are awarded where information is provided relating to the provision of energy efficient white goods, or where energy efficient white goods are supplied in accordance with the criteria in the table below for each dwelling:

## Criteria

Where the following appliances are provided and have an A+ rating under the EU Energy Efficiency Labelling Scheme:

- Fridges and freezers or fridge-freezers

Where the following appliances are provided and have an A rating under the EU Energy Efficiency Labelling Scheme:

- Washing machines and dishwashers

### AND EITHER

- Washer-dryers or tumble dryers have a B rating

### OR

- Where washer-dryers or tumble dryers are not provided, information on the EU Energy Labelling Scheme is provided to each dwelling where this is the case

Note: Where washer dryers are provided it is not necessary to provide a washing machine to obtain this credit

If **no (or not all) white goods are provided** but information on the EU Energy Efficiency Labelling Scheme of efficient white goods is provided to each dwelling where this is the case

In order to award credits, any white goods provided must be compliant with the above criteria (even if not all white goods listed above are provided).
